
Coronavirus / COVID-19 Warning & Disclaimer

I acknowledge the contagious nature of COVID-19 and other communicable diseases and voluntarily assume the risk that I may be exposed to or infected by COVID-19 and/or other communicable diseases by participating in the Bagel Run Event.

I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and/ or death. I understand that the risk of becoming exposed to or infected by COVID-19 is in connection with my participation in any race-related activities, and personally assume this risk.

I certify that, to the best of my knowledge, I have not had symptoms commonly associated with COVID-19 (fever/chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste/smell, sore throat, congestion or running nose, nausea or vomiting, diarrhea) in the past fourteen (14) days, nor have I been directly exposed to an individual contagious with COVID-19 in the past fourteen (14) days.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in use of JCC of Dallas facilities and JCC of Dallas program participation and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, I sustain while participating in JCC of Dallas programming and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death. I further certify that I am in good health and that I have no conditions or impairments which would preclude my safe participation in JCC of Dallas programming or use of JCC of Dallas facilities.

I agree that I will notify the Aaron Family JCC/Bagel Run Race Director at kward@jccdallas.org if I develop symptoms or am exposed between the time of my signing this waiver and my arrival at the race event.

I agree that, if I develop clear symptoms and/or receive a positive test for COVID-19 in the seventy-two (72) hours after the event, I will notify the Aaron Family JCC/Bagel Run Race Director at kward@jccdallas.org. I understand my personal information will be kept confidential, and CDC guidelines for contact tracing and notification will be followed.

I agree to follow the race-specific Safety Protocols as found in the Racing Systems Inc. COVID-19-Protocols - Event Guide and/or any subsequent updates that will be communicated to me by the Race Directors via email, website and/or in-person communication. I understand that those not cooperating will be asked to leave, and that runners could be subject to disqualification if they themselves, or their associated crew/pacers fail to follow the protocols.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation at the event ("Claims"). On my behalf I hereby release, covenant not to sue, discharge, and hold harmless The Aaron Family JCC/Bagel Run, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Aaron Family JCC/Bagel Run, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Racing Systems Inc. event.
