## DAN LEVITAN



Dan Levitan has been a principal with the privately held investment firm, The PNL Companies, based in Dallas for 23 years. He recently started an alternative investment platform with one of his PNL partners known as LNP Capital. PNL and LNP specialize in purchasing distressed commercial real estate loans and properties throughout the country. Locally, Mr. Levitan has been instrumental in the acquisition, repositioning, and disposition of many prime DFW properties including the 2100 Ross office building in downtown Dallas, Radio Shack's former corporate headquarters complex known as the Tandy Center in downtown Fort Worth, and more than 100 acres of high-profile, commercial, Tollway frontage land in Frisco.

Prior to coming to Texas in 1999, Mr. Levitan held several positions in the real estate investment and advisory business in Southern California. He was previously the Director of Real Estate Consulting at Price Waterhouse in Los Angeles, and prior to that a Consulting Manager with Kenneth Leventhal & Company, which was subsequently absorbed into the real estate practice at Ernst & Young. He remains a licensed California real estate broker.

Mr. Levitan holds an MBA from the University of Southern California in Finance and Real Estate and a BA from the University of Pennsylvania in History and International Relations.
